### Minutes of the Meeting

The Vice-Chancellor welcomed the members of Board of Management and commenced the proceedings by quoting the following couplet from "Thirukkural" along with its message.

### Meaning in English

The Vice Chancellor has narrated the present pandemic situation how it is affecting regular affairs of the University. Considering the increase in covid infections, University has closed the campus for all physical activities with effect from 08-05-2021 until further notice. However, teaching and administrative works are conducted online with full ICT resources of the University.

#### Item No. 1.

Besides many of AMET Faculty, Staff and Students are getting affected with COVID19 during this pandemic period, the following two employees of AMET lost their lives due to COVID19

- 1. Chief Engineer Mr. PS. Sridhar, Associate Professor of Marine Engineering
- 2. Mr. S. Suresh, Assistant Registrar-Academics

The Vice Chancellor has explained the efforts taken by the University Management in extending monetary support to the COVID affected Faculty and sponsoring of complete education expenses of the children of Faculty/Staff who died because of COVID19. The Vice Chancellor also informed to the Board that University has established AMET Covid Cell with two medical Doctors as Members besides Faculty and Staff. The Cell provides support in terms of medical advice, arrangement for the treatment, providing required supplies for the Covid affected Faculty/Staff and other related activities. The Members of the Board of Management have appreciated the relief initiatives and COVID Cell activities of the University.

**RESOLVED** that the Board of Management on behalf of the University, Faculty, Staff and Students records sincere condolence for their loss.

Dr RK Chauhan opined that AMET being a de no category deemed to be University such efforts will get success in the days to come.

Members have also emphasized the importance of exhibiting the unique and core strength of the University in the expected NAAC and NBA visits. Faculty are to be oriented equally. University Authorities are advised to maintain the sustained improvement of the University in all the quality attributes.

During the report period, a total of 28 Non-Teaching Staff and 46 teaching Faculty have been appointed in the existing approved vacancies. #### Item No-5:

The Vice Chancellor has submitted reports on various initiatives taken with reference to Academics, Examination, Research and Quality attributes of the University

a) Academics and Quality Attributes: The Internal Quality Assurance Cell (IQAC) of the University has consolidated all academic commitments such as organizing conferences, conducting mandatory meeting, publishing articles etc.. for each Department. In this regard, an Academic Commitment Chart for Department and individual Faculty are prepared and distributed to the concerned Department/Faculty. Based on the Commitments made by Departments and their Faculty members expected outcome on quality attributes are presented in a summarized manner along deliverables.

- b) Examinations: The University has completely shifted to online mode with reference to the conduct of all internal and external examinations and PhD public viva voce.
- c) Research: The Centre for Research has conducted all academic research related proceedings through online for the smooth administration of PhD Programmes.

**RESOVED** that the Reports on Academics, Examination, Research and Quality attributes of the University are noted and appreciated. The Members have recorded their special appreciation for having conducted all examination and evaluation process online which facilitated the student progression without any delay or difficulty.

#### Item No-6

The Registrar in charge has reported that with the approval of Vice Chancellor, the following faculty members have been assigned new position along with their academic responsibility. They would monitor all the activities of staff members in their respective functional area and fine tune the progress in the activities.

**RESOLVED** that the appointments of University Faculty as Deans, Directors, and Coordinators (total 17 numbers) to undertake special assignments are approved and ratified.

#### Item No-7

The Dean-Academics has submitted a proposal for the introduction of New Programmes in the Department of Information Technology which also may be

renamed as Department of Computer Science to accommodate all the New Programmes.

### List of new programmes to be introduced

- 1. B.Sc., Data Science
- 2. B.Sc., Artificial Intelligence and Machine Learning
- 3. B.Sc., Robotics and Artificial Intelligence
- 4. B.Sc., Computer Science and Business Systems

The fields of Data Science, Artificial Intelligence, Robotics, Machine Learning and Business Systems are fast evolving and inevitable in every field of application. In the future, in all operations these scientific aspects will get involved. Hence, introduction of these programme by a Maritime University will be the need of the hour to augment the shipping and allied industries which are the thrust areas of the University.

A Special Expert Committee is constituted by the Vice Chancellor to analyse the requirement, prospects, design and develop curricula and syllabi for the programmes. The Committee has met online twice and provided detailed recommendations along with required curricula and syllabi

The following details are considered by the Members of the Board of Management to accord permission to introduce the new programmes

- 1. Justification and job prospects of the New programmes
- 2. Curriculum and Syllabus of all the four programmes
- 3. Details on Books, Journals, Labs and Infrastructure to meet the requirements of new programmes
- 4. Details of Undertaking Letters to be submitted to the UGC for approval

#### Note:

Dr Mamta Rani Agarwal has opined that University can introduce UG courses with Honours and specialization. She further opined that overseas Universities shall be contacted for initiative such as Semester Abroad Programmes or Final Year projects at overseas Universities.

Dr MS Palanisamy has conveyed that University shall also introduce more PG programmes in advanced areas of science and technology.

**RESOLVED** that considering the merit of the proposal, approval is granted for the introduction of four New Programmes in the Department of Information Technology which also be renamed as Department of Computer Science to accommodate all the four New Programmes.

#### Item No-8:

All the regulatory and statutory authorities of the University are emphasizing the placement opportunities for the student of all the Degree Programmes. The Centre for Placement and Training has prepared a Placement Policy. The policy document, modalities for implementation and procedures are discussed in length and the members have expressed their appreciation for the same.

**RESOLVED** that the Placement Policy 2021 of the University is approved and the Centre for Placement and Training shall emphasize on more practical oriented training towards placement.
