**16. Multidisciplinary / interdisciplinary**

AMET has been established originally as a Maritime focused Institution. However, since 2015, the University has widened its scope and expanded its academic programmes to contemporary studies also. The University is now offering courses in the Faculty of Maritime Studies, Engineering, Technology, Management Studies, Business Administration, Commerce, Liberal Arts, Life Sciences and Science and Humanities. In addition to this vertical expansion into the multidisciplinary and interdisciplinary domains, under the Choice Based Credit System (CBCS) and with the insights and inputs from the National Education Policy 2020, the University is offering diverse range of multidisciplinary and interdisciplinary courses to provide the students with wholesome knowledge and a wide scope for the access to all walks of the knowledge.

The University is promoting the industry interaction in true spirit which provides students the real-time exposure to multidisciplinary and interdisciplinary knowledge. The University promotes Massive Open Online Courses (MOOCs) through NPTEL and other platforms as a part of their curriculum under the scope of open electives. Students and Faculty are encouraged to take up research studies in interdisciplinary research labs and specialized centers. PhD Research is largely promoted as interdisciplinary and multidisciplinary. Similarly, the funding for seed money and student project is more focused towards supporting interdisciplinary and multidisciplinary research. The Minor Degree programme introduced by the University expands the scope of interdisciplinary and multidisciplinary in academics where students from Engineering Discipline can take a minor degree in Management Studies. Dual Degree are also permitted as per the National Education Policy for which provisions are made in the CBCS regulations of the University and students are getting benefit of the same.

### **17.Academic bank of credits (ABC):**

There is a set credit requirement for completing the university's current program offerings. Every program offers both Core and Elective courses, giving students a flexible environment in which to select their courses. Every semester, the student has the option to select an elective from the university's bank of credits. As a result, the student is assigned elective courses. Each semester, the student is required to complete a certain amount of credit as set by the university. However, if the student does not complete the required amount of credit in that semester, they will still have the opportunity to earn it in later semesters. There is no required credit requirement for a student to advance to the next semester, which allows the student the opportunity to pass the prior course(s) in the next semester(s) and aids in his academic advancement in the program. To finish the program, each student must meet a certain number of credits, though. The university also offers optional credit courses under the names "Add on" and "Value Added". A student can add credit to his academic bank by selecting from a variety of possibilities. One of the key ideas of NEP 2020 for educational transparency and learning from the best institutions in the nation is the Academic Bank of Credits (ABC). Beginning with the current academic year 2021-2022, AMET University is adopting the Academic Bank of Credits in accordance with the rules given by the Ministry of Education, Government of India, for the Universities. The student registration procedure has commenced. To date, almost 80% of students have registered with Digi Locker. The Academic Awards have been uploaded by the University to the NAD.

### **18.Skill development:**

Realizing the immense value of skill development along with knowledge integration through regular degree courses, the University has ensured that a minimum of 20% of the regular courses in all degree programmes are having skill development contents. The University places a high priority on student skill development by offering industry-required skill development programs every semester. The courses are aimed to give students admitted to the program information and skills by combining the academic and practical components. AMET also offers soft skills, life skills, values, etc. Each department has national and international conferences to share the most recent developments in their fields of study and the abilities that employers are looking for. Additionally, it is encouraged for students in each degree to participate in internships and skill-based training programs in the industry. The project and dissertation are essential elements in helping students advance their talents. Courses that are skill-based



are offered by each department as "Value Added" and "Add On" courses. These classes are designed to give students the chance to acquire modern information and abilities.

**19.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)**

In addition to offering one topic in postgraduate programs, AMET promotes the study of Hindi by hosting value-added courses, webinars, seminars on law, culture, and heritage, and celebrations of Hindi Diwas. Additionally, cultural values from Indian tradition are instilled in students through subjects like Indian Tradition, Indian Constitution, Business Ethics, Professional Ethics, and Essence of Indian Knowledge Tradition that are included in the curriculum of various programs. Additionally, AMET commemorates a number of cultural holidays, including Ugadhi, Onam, and Pongal, which are both national and regional holidays. The celebrations of Holi in the northern states of India and the new year in Andhra Pradesh, Telangana, and Karnataka have encouraged a secular atmosphere and cultural blending among the student body. In order to promote social responsibility and solidarity, AMET offers a forum for students to showcase cultural, regional, and social welfare events. AMET also runs a number of online programs, such as using computer programs for quizzes, essay completion, sketching, and poetry writing to teach students about Indian systems.

**20.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

A key demonstrative tool for student-centered instruction that concentrates on gauging student success by results is outcome-based education, or OBE. The process of quality assurance and improvement involves assessing whether the established learning objectives adhere to an overall standard of quality. The goal of the outcome-based education (OBE) system is to measure students' abilities, and one of its main tenets is their learning outcomes. The statements that list the information and abilities a student should have at the end of a course are called course outcomes. The objectives of every course are focused on cognitive skills, specifically Remembering, Understanding, Applying, Analyzing, Evaluating, and Creating. Program outcomes are what students should know, be able to do, and think like at the end of the program. Course outcomes can be used to measure program outcomes directly. The foundation of the outcome-based education paradigm is the definition of certain variables known as Graduates Attributes (POs). AMET University is dedicated to creating learning outcomes that align with students' broader interests. The syllabus includes explicit references to the course objectives, learning outcomes in terms of program outcomes, program

specific outcomes, and course outcomes, all of which are promised to be strictly adhered to. In order to best realize the graduate traits and implement the spirit of NEP, AMET University is dedicated to a strong assessment system.

**21.Distance education/online education:**

After the implementation of National Education Policy 2020 which aims to enhance the Gross Enrolment Ratio of the Nation, there is an increased attention on the Distance and Online Education. With the learnings and experience during the Covid 19 Pandemic, AMET has excelled in integrating technology into every aspect of education right from the curriculum to the level of examination. AMET has produced over 22000 alumni who are in exalted positions all over the world. The University is making impact on maritime and allied education globally. The University gained good reputation at global level. With these background, the University aimed to offer appropriate programmes through distance and online education mode.

Hence, the University established the Centre for Distance and Online Education (CDOE) to offer following programmes through Open and Distance Learning (ODL) / Online (OL) modes after the approval of the UGC-Distance Education Bureau (DEB).

- Master of Business Administration (MBA) in Shipping and Logistics Management
- Bachelor of Business Administration (BBA) and
- Bachelor of Commerce (B.Com)

AMET Deemed to be University has already obtained approval and No Objection Certificate from the AICTE to offer MBA-Shipping and Logistics Management in both ODL and OL modes as per the UGC (ODL Programmes and Online Programmes) Regulations, 2020. Efforts are being made to develop self-learning materials and e learning materials and to host them in a robust LMS. E contents in four quadrant model as per UGC guidelines are being prepared by using the Audio Video Lab, Media Centre and Educational Resource Material Center (EMRDC) of the University. The application to get approval of UGC DEB will be submitted in the Academic Year 2023-24.
