## NOTIFICATION

Whereas, the Central Government is empowered under Section 3 of the University Grants Commission (UGC) Act, 1956 to declare, on the advice of the UGC, an Institution of higher learning as deemed to be University.

- 2. And whereas, in exercise of the powers conferred by Section 3 of the UGC Act, 1956, the Central Government vide its Notification No.9-19/2005-U.3 dated 21.08.2007, on the advice of UGC, had declared Academy of Maritime Education & Training, Kanathur, Tamil Nadu as an Institution deemed to be University under denovo category, for the provisional period of five years, with effect from the date of disaffiliation of the Institute from its affiliating University.
- 3. And further whereas, the functioning of Academy of Maritime Education & Training, Kanathur, Tamil Nadu was reviewed by the UGC with the help of its Expert Committee during 31st January to 2nd February, 2018. The report of the Expert Committee was placed before the Commission in its 530th meeting (Item No.2.06) held on 20.03.2018. The Commission considered the report and the following resolution was forwarded to this Ministry:

"Considered and approved with the condition that the suggestions by the visiting Expert Committee, if any, will be addressed within a period of six months and the compliance report would be submitted alongwith documentary proof to UGC."

4. Now, therefore, in exercise of the powers conferred under Section 3 of the UGC Act, 1956, the Central Governmen; on the advice of the UGC, do hereby extend the deemed to be University status to Academy of Maritime Education & Training, Kanathur, Tamil Nadu from 21.08.2012 to 30.06.2019 with the condition that the Institution shall submit compliance report w.r.t. suggestions / deficiencies pointed out by the UGC Expert Committee. This is further subject to condition that the

Institution deemed to be University shall improve its performance through its ranking / grading in NIRF / NAAC.

5. The all other conditions mentioned in the earlier Notification(s) of this Ministry as well as the Rules / Regulations of UGC and other Statutory Councils, issued from time to time, shall continue to be adhered by Academy of Maritime Education & Training, Kanathur, Tamil Nadu.
