We wish to bring to your kind notice that the AMET Deemed to be University was granted with MBA-Shipping and Logistics Management programme to be offered through Open and Distance Learning (ODL) mode from the academic year 2022-23 with an approved intake of 1000 students.

However on the renewal for the academic year 2023-24, it is mentioned in the AICTE approval copy (Ref-2) as MBA instead of mentioning the nomenclature as MBA-Shipping and Logistics Management.

For your kind information, we have not changed the nomenclature of MBA-Shipping and Logistics Management for the AY 2023-24, but it is misrepresented as MBA instead of MBA-Shipping and Logistics Management, may be due to portal error. We request you to accept the nomenclature as MBA-Shipping and Logistics Management for the ODL mode also.
